Reference the game on September 21... as of today, we have full staffing that afternoon. Barring any unforeseen emergency, we will have a car at Hwy 210 and 510th to assist with traffic. You may also consider some barricades/signs on the side streets for local traffic only if you have those available. Just a thought. Hopefully Hwy 69 gets opened back up soon!!!

Reference the question that came up about writing municipal citations in TRACS, I followed up with the DOT (TRACS) and the Clerk of Court:

If the city has a municipal ordinance that they want enforced, it may be written and filed through TRACS if it is a <u>criminal</u> code. Refer to your city attorney to determine if the violation is a civil infraction or a criminal charge; the code needs to be specific.

If you have criminal citations you want written, you can identity which ones you would like entered into TRACS. You would provide those to the Clerk of Court for entry. Once that is done, you would let us know, and I could ask the DOT to push those to us within Tracs. We would then have a local option for Slater to write under that ordinance. (Please keep in mind that the Sheriff's Office maintains discretion on charging.) The citation goes to the Clerk of Court and they set up a case, just as they would for a state charge. If the subject pleads not guilty, they would link in your City Attorney and it would be up to them to prosecute the case.

Municipal Civil infractions are a different case. The City of Slater/city attorney would have to manually effile the citation and pay a \$95 fee up front. The city attorney again is responsible for the prosecution of the case. I attached the information I had previously provided, as that stands for infractions. I did learn that the filing fee increased to \$95, so we need to update that at the citation for court costs.

Hope you are doing well.

I am reaching out to see if you could look into some potential traffic control/support for Slater. With Highway 69 closed currently, we are seeing a significant increase in traffic through Slater prior to and after the home ISU football games. Prior to the games it seems that traffic is scattered around enough that it isn't creating any larger congestion or concerns. However, after the games the traffic flow seems to be consistent and long lasting. Because of this, we have seen an increase in people leaving R38/Linn St, and proceeding down city streets at faster than preferred speeds to try and cut through town instead of through the R38/210 intersection. It is my hope that you could consider providing an officer to possibly direct traffic for a period of time post game to assist with the flow of traffic at this intersection.

If that is not an option, would you happen to have any other possible solutions that you could assist our town with to help eleviate this concern?
